To book the performer(s) a **\$50.00 non-refundable** deposit is required for each performer booked for the event.

-Deposit can be made by submitting a complete credit card authorization form (below). The remaining balance must be paid by **CASH** or company check to the performer(s) immediately after the performance. Balances paid with credit card will be charged an additional fee of 4% to cover bank charges. Returned checks will incur an additional \$25.00 Returned Check Charge.

-To book the performer(s) a **\$75.00 non-refundable deposit** is required.

-Performer(s) must start the performance within 15 minutes of scheduled performance time, or \$25.00 will be charged per 15 minutes interval thereafter.

-Performers may receive tips in an appropriate manner, thrown over the performer during the show or handed to the performers after the performance.

-Performers are not to be touched or harassed. Any performer feeling threatened may leave the event at any time and full fees will be due.

-Parking **MUST** be provided for the performer. If the client does not have parking available, parking fees are to be reimbursed to the performer with the payment for performance.

-48-hours verbal cancelation notice required or **FULL FEES DUE**. Any fees incurred such as returned checks fees, or for any additional cost incurred by the performer such as valet parking, or balance of fees not paid at time of performance, shall be charged to the client's credit card. In addition to the 4% Bank Charge Fee. An additional 5% Late Fee Surcharge shall be added for all late pay accounts.
